ODDS AND ENDS

\$90 dues for July through December 2005 are due by **August 1st**. To avoid your pool and clubhouse access being terminated, pay your dues by August 15th. To avoid a \$10 late fee, pay your dues by **September 1st**. Invoices are only mailed once a late fee has been assessed. There are now 2 payment options. Payment Option # 1: Pay by check and Payment Option # 2: Auto draft, which can be Quarterly (January, April, July, and October), Semi-annual (January and July), or Annual (January). We would like to encourage the use of the auto-draft form, which is working well for those who have already signed up. Please see the enclosed auto debit form or you can print one off from the website.

Please make sure that Leah Kackley (ahoawelcome@gmail.com) has your current email address. This a good way to ensure that you are on the email list for any quick announcements that might need to be made.

Stop signs and street signs are not the place for personal signs in Avalon. Every time someone tapes a sign to the post, it takes off paint. This is just a reminder for all of the up coming garage sales, put your signs on your on own posts. Wal-Mart sells them for about \$0.97 each.

Avalon is organizing a Neighborhood Watch Program and needs your help. We will need "Block Captains" from all areas of Avalon, preferably one per street. New access system

- Recently you received a letter, and most of you your access cards, about and for the new access system at the clubhouse. The letter that was mailed is posted on the website. Please refer to it for additional information. The system was activated on May 25th, 2005, and is working fine.

As mentioned in the letter, a recent rash of vandalism prompted the purchase of this new system. The system tracks the cards that are being used to access the pool area and, hopefully, will discourage future vandalism.

Parents: Please remember that **children under the age of 16 are not allowed** to use the pool facilities without being escorted by an adult resident of Avalon.

If you move, please leave the cards for the next resident of your home. This will alleviate the need for the Board to purchase additional cards.

If you currently have a key to the exercise room, please discard it as it no longer has a use.

New Pool Construction

- The board is currently exploring the possibility of building an additional pool. We have been advised that the most cost effective approach to this is to install an additional pool on the same lot as the current pool. We are currently in the process of obtaining a full cost estimate and rendering. As this construction will have to go up for a full vote by all residents, you will receive additional information with the ballot.

The proposal that we have asked for will double our pool use capacity.

Below is an outline on what you will need to do to reserve the clubhouse or receive a key to the exercise room.

BOOKING OF CLUBHOUSE - ONLY FOR RESIDENTS WHO ARE CURRENT ON THEIR DUES!

1. Contact Cindy and inquire about date availability.
2. The clubhouse will be booked to the Resident only if dues are current.
3. Review "CLUBHOUSE CHECKLIST" with Cindy, provide a \$50.00 deposit and Cindy will provide a key.
4. Resident is to return the key to Cindy immediately after the event is finished and the clubhouse cleaned.
5. Cindy will inspect the Clubhouse & checklist, then return deposit to Resident if all items are satisfactory.

Please make an honest effort to slow down and obey all traffic signs.

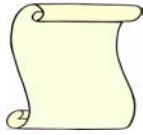


SUMMERTIME REMINDER

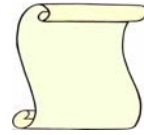

For those homes with sidewalks, please remember to remove grass clippings and any weeds that may sprout.



Covenant Corner



Recently, there have been some complaints made to the board regarding the placement of satellite dishes. Please be aware that the covenants were amended in October of 2003 to address this issue. The covenant states:

'Satellite dishes should be installed to the rear of residence behind any existing fencing. If this is not a viable choice due to problem with azimuth alignment with satellite, placement should be within 15 feet of rear corner on either side of residence affixed to eave of roof or placed on pole not to exceed 4 feet high and not more than 3 feet from residence.

Any deviation to Satellite Dish placement must be approved by the Avalon Architectural Review Committee.'

If you are not in compliance, please address this issue at as soon as possible.

Additionally, there have been complaints regarding parking along the streets. Our streets are not designed to accommodate on-street parking and parking in the streets obstructs the flow of traffic. For safety reasons, please do not park in the streets.
